

LIVE NATION Responsibility Has Its Rewards Sweepstakes Official Rules



NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

1. How to Enter. To enter, attend any Live Nation® concert in any one of the following Live Nation venues in the United States during the 2011 summer concert season.

Register as a designated driver at the designated driver booth at the venue by completing the designated driver pledge form. To enter without attending a Live Nation concert, register online at www.rhir.org/livenation.asp or send a postcard (no envelopes please) with your name, e-mail address, mailing address, work or home phone number, your favorite Live Nation concert venue (must be one of the 5 participating venues) and a statement of no more than 100 words on why you believe it is important to be a designated driver at a concert to TEAM Coalition ("Sponsor"), 1800 Diagonal Road, Suite 600, Alexandria, VA 22314. All entries submitted at a Live Nation venue must be received by the end of the last 2011 summer concert at a participating Live Nation venue. All online entries must be submitted by Friday, October 28, 2011. All mailed entries must be postmarked by Monday, October 24, 2011 and received by Friday, October 28, 2011.

You may only enter by mail one (1) time for one (1) Live Nation venue. Only one (1) entry per postcard. All entries become the sole property of the Sponsor and receipt of entries will not be acknowledged or returned. Delivery of prize may require a street address (no P.O. Boxes). Sponsor is not responsible for lost, late, incomplete, mutilated, invalid, unintelligible, postage-due or misdirected entries, all of which will be disqualified. Sponsor is not responsible for the failure of any Live Nation venue to retain any entries or for any human error in connection with the retention of entries. No facsimiles, mechanical reproductions alterations or forged entries. Only fully completed entry forms are eligible and incomplete entry forms will be disqualified.

2. Start/End Dates. Sweepstakes begins on Monday, August 1, 2011 and ends Friday, October 28, 2011.

3. Eligibility. Participation is open only to legal residents of the U.S. and Canada, age 21 and over as of date of entry, and who possess a valid driver's license. Void in Puerto Rico, outside of the U.S. and Canada, and where prohibited, taxed or restricted by law. Employees, officers & directors of TEAM Coalition ("Sponsor") are ineligible.

4. Random Drawings/Odds. On or about Monday, October 31, 2011, each of the five (5) Live Nation venues will randomly select one (1) Grand Prize Winner from a pool of all entries received at each venue or received by TEAM via mail and identified as the favorite Live Nation venue on such entry forms for a total of five (5) Grand Prize Winners. Each Grand Prize Winner will receive the Sweepstake's Prize. Odds of being chosen as a Grand Prize Winner depend on the number of eligible entries received for each venue. By entering the Sweepstakes, entrants agree to be bound by these rules and the decisions of the judges, which will be final and binding in all matters relating to the Sweepstakes. Canadian residents, if selected as a Grand Prize Winner, must correctly answer a mathematical skill-testing question by phone or mail in order to win a prize. Contest not produced or executed by any Live Nation or any other Live Nation affiliated entity including employees, officers or directors of Live Nation and or its affiliated partners (collectively, the "Live Nation Entities").

5. Prizes. Five (5) Grand Prizes each consisting of two (2) tickets to a Live Nation concert at one (1) of the five (5) participating Live Nation venues during the 2012 summer concert season. Total ARV for each Grand Prize: \$200. All winners will be solely responsible for all applicable taxes on prizes and any other costs not indicated as forming part of the prize as well as optional travel insurance. Winners are responsible for ensuring they have proper travel documentation. Winner must agree to a background check and shall be required to sign a Prize Waiver/Affidavit prior to accepting the Prize. Winners must be available to attend the prize events on the dates of such events; otherwise, such prize will be forfeited and awarded to an alternate. Restrictions and blackout dates apply.

6. Notification. Entrants will be notified of their Grand Prize Winner status by e-mail or telephone on or about Tuesday, November 1, 2011. All winners will be required to sign and return, where legal, an Affidavit of Eligibility and Liability/Publicity Release. If winner cannot be contacted, if any prize is returned as undeliverable, or in the event of noncompliance with these Sweepstakes rules and requirements, an alternate winner may be selected. Limit one prize per person. Concert or event dates and times determined in the sole discretion of the Live Nation Entities, as applicable, and are subject to change and/or cancellation.

7. Conditions. All taxes are the sole responsibility of the winners. Participation in Sweepstakes and acceptance of prize constitutes winners' permission for Sponsor and Live Nation Entities to use their respective names, addresses (city and state/province), likenesses, biographical information and any mail-in entry statements for advertising and promotional purposes without notice or additional compensation, except where prohibited by law. In addition, prize winners, by accepting a prize, agree to participate in promotional events and activities, as requested by the Sponsor and/or Live Nation Entities without additional compensation. Without limiting the foregoing, Sponsor may disqualify any entrant/winner having an outstanding or prior warrant, indictment, citation or conviction involving alcohol or alcohol-related incidents, regardless of when such incident occurs. Sponsor and Live Nation Entities are released from any liability from the contestants' participation in the sweepstakes.
