To enter without attending a National Hockey League® game send a postcard (no envelopes please) with your name, e-mail address, mailing address, work or home phone number, the name of your favorite National Hockey League® team and a statement of no more than 100 words on why you believe it is important to be a designated driver at a sporting event to TEAM Coalition ("Sponsor"), 1800 Diagonal Road, Suite 600, Alexandria, VA 22314. All mailed entries must be postmarked by Monday April 2, 2012 and received by Friday April 6, 2012. All entries submitted at a National Hockey League® arena must be received by the end of the last 2011-2012 regular season game at the respective arena. All entries submitted on the TEAM Coalition website must be submitted by Monday April 9, 2012.

You may enter as many times as you like, however, mailed entries are limited to one (1) entry per postcard and each mailed entry will be counted as one entry. All entries become the sole property of the Sponsor and will not be acknowledged or returned. Delivery of prize may require a street address (no P.O. Boxes). Sponsor is not liable for lost, late, stolen, invalid, postage-due or misdirected entries. Sponsor is not responsible for typographical or other errors in the offer or administration of the Sweepstakes, including, but not limited to, errors in advertising, the Official Rules, the selection and announcement of winners, or the distribution of any prize. No photocopies, facsimiles, other mechanical reproductions, or forged entries are allowed. Only fully completed entry forms are eligible and incomplete, altered, defaced, mutilated or illegible entry forms will be disqualified.

2. Start/End Dates: Sweepstakes will begin on Thursday, October 6, 2011 and will conclude at the end of the National Hockey League® 2011-2012 regular season on Saturday April 7, 2012.

3. Eligibility: Participation is open only to legal residents of the U.S. and Canada, age 21 and over in the U.S. as of date of entry and of legal drinking age in the province or territory in which they reside in Canada as of date of entry, and who possess a valid driver's license. Void in Puerto Rico, outside of the U.S. and Canada, and where prohibited, taxed or restricted by law. Subject to all national, state, provincial and local laws and regulations. Employees, officers and directors, and families of employees and officers and directors of Sponsor and the National Hockey League, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC and the member clubs of the National Hockey League (collectively, the "NHL Entities"), the advertising and promotional organizations for this Sweepstakes, and any of their respective subsidiaries or affiliates are ineligible to participate in this Sweepstakes.

4. Random Drawings/Odds: On or about Friday April 13, 2012, one (1) Finalist from a pool of all entries received via an in-arena booth, the TEAM Coalition website, or received by Sponsor via mail will be randomly selected for each of the participating National Hockey League® teams for a total of thirty (30) Finalists ("Finalists"). One (1) drawn Finalist (of the thirty (30) Finalists) will receive an All-Star Game prize as detailed below. One (1) additional Finalist will be drawn from the remaining twenty-nine (29) Finalists to win the Regular Season Game prize as detailed below. Odds of being chosen as a Finalist depend on the number of eligible entries received for each arena/team. The odds of a Finalist winning an All-Star Game prize are 1:30, and the odds of a Finalist winning the Regular Season Game prize are 1:29. By entering the Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sweepstakes judges, which will be final and binding in all matters relating to the Sweepstakes. Canadian residents, if selected as a Finalist, must correctly answer a mathematical skill-testing question without assistance of any kind, whether mechanical, electronic or otherwise, by phone or mail before such Finalist can be declared a winner of any prize. This Sweepstakes is not produced or executed by any NHL Entity.

5. Prizes: One All-Star Game prize consisting of a trip for two (2) people to the 2013 NHL® All-Star Game, including roundtrip coach-class air transportation for winner and one (1) travel companion from the gateway airport nearest to winner's residence (if necessary), a minimum of two (2) nights hotel accommodations as determined by Sponsor (single room, double occupancy, if necessary), and two (2) tickets to the 2013 NHL® All-Star Game in Columbus, OH. Total ARV of All-Star Game prize: \$1,500 U.S. If

the NHL® All-Star Game prize winner lives within a reasonable driving distance of Columbus, OH, ground transportation (mileage and parking reimbursement) may be provided in lieu of air transportation and no compensation or substitution will be provided for difference in prize value.

One Regular Season Game prize consisting of two (2) tickets to a 2012-2013 regular-season NHL® game in the city of the team for whom the Finalist has been selected as the Designated Driver for the Season. Total ARV of Regular Season Game prize: \$250 U.S.

All winners will be solely responsible for all applicable taxes and fees on prizes and any other costs not indicated herein as forming part of the prize, as well as optional travel insurance. All-Star Game and Regular Season Game prize winners will be notified of their winning status by e-mail or telephone after the completion of the 2012 Stanley Cup® Final. All winners and travel companions will be required to sign, have notarized and return, where legal, an Affidavit of Eligibility and Liability/Publicity Release prior to receiving any prize. For all prizes, the travel companion will be required to sign and return a travel release prior to ticketing. If the travel companion is a minor, he/she must travel with his/her parent/legal guardian who must sign the release.
